

RESOLUTION NO. 2025-2455

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AUTHORIZING THE SUBMISSION OF AN APPLICATION FOR LAND AND WATER CONSERVATION FUNDS (LWCF) TO ARIZONA STATE PARKS AND TRAILS, AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS RELATING TO SAID APPLICATIONS, AND AUTHORIZING THE CITY MANAGER TO EXECUTE A GRANT AGREEMENT (IF GRANT FUNDS ARE AWARDED), AND AUTHORIZING THE CITY MANAGER TO APPROVE THE REQUIRED BUDGET TRANSFER (IF GRANT FUNDS ARE AWARDED).

WHEREAS, the 2023 Parks Master Plan was informed by input from staff, stakeholders, user groups, and thousands of residents gathered a robust outreach process; and

WHEREAS, this activity was identified as a recommendation in the 2023 Parks Master Plan (p. 119); and

WHEREAS, it is in the best interest of the City to apply for a Land and Water Conservation Fund (LWCF) grant to relocate the dog park at Goodyear Community Park to expand and enhance the user experience; and

WHEREAS, the projects qualify as eligible projects under the LWCF program; and

WHEREAS, the resources for the match requirement in the amount of \$1,500,000.00 have been identified in the CIP;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

SECTION 1. The City Manager, or her designee, is hereby authorized to submit an application to Arizona State Parks and Trails for the Goodyear Community Park dog park relocation project for an amount not to exceed \$1,500,000.

SECTION 2. If the grant application is awarded, the City will enter into a Grant Agreement with the State to implement the projects or programs that have been approved by the State.

SECTION 3. The City Manager is hereby authorized to execute all documents relating to these applications and any grant offer resulting from such applications.

SECTION 4. If grant funds are awarded to the City of Goodyear, the City Council hereby approves necessary budget transfers in the amount of the awarded funds.

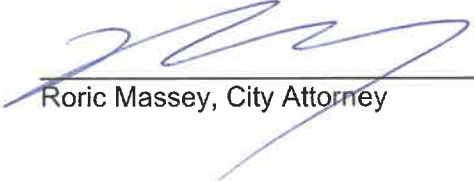
