

RESOLUTION NO. 2025-2477

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, RATIFYING THE CONDITIONAL APPROVAL AUTHORIZING THE SUBMISSION OF AN APPLICATION FOR ARTERIAL REHABILITATION AND RECONSTRUCTION PROGRAM (ARRP) FUNDS TO THE MARICOPA ASSOCIATION OF GOVERNMENTS.

WHEREAS, on May 1, 2025, the Mayor granted conditional approval to submit an application for Arterial Rehabilitation and Reconstruction Program (ARRP) grant funds for assistance in performing mill and overlay pavement rehabilitation treatment on Estrella Parkway, from McDowell Road to Van Buren Street, contingent upon approval by the Goodyear City Council by resolution; and

WHEREAS, this project and the resources for the thirty percent (30%) match requirement will be funded by FY27 Highway User Revenue and General Fund; and

WHEREAS, the project qualifies as an eligible project under the Arterial Rehabilitation and Reconstruction Program; and

WHEREAS, the pursuit of this grant is to the benefit of the citizens of the City of Goodyear;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

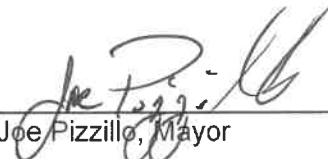
SECTION 1. Ratify the current application submission to the Maricopa Association of Governments for the Arterial Rehabilitation and Reconstruction Program for performing mill and overlay pavement rehabilitation treatment on Estrella Parkway, from McDowell Road to Van Buren Street, for an amount not to exceed \$2,278,703.

SECTION 2. If the grant application is awarded, the City Manager is authorized to enter into an Intergovernmental Agreement (IGA) with the Arizona Department of Transportation to implement the projects or programs that have been approved by the Maricopa Association of Governments.

SECTION 3. The City Manager is hereby authorized to execute all documents relating to this application and any grant agreement offered as a result of grant funding.

SECTION 4. If grant funds are awarded to the City of Goodyear, the City Council hereby authorizes the City Manager to approve the necessary budget transfers in the amount of the awarded funds.

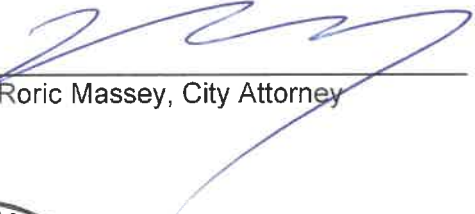
