

RESOLUTION NO. 2025-2492

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, TO APPROVE THE IMPLEMENTATION OF THE 2025 REVISION OF THE GOODYEAR EMERGENCY OPERATIONS PLAN (EOP), REPLACING RESOLUTION NO. 16-1750, AND AUTHORIZING THE MAYOR TO SIGN THE LETTER OF APPROVAL AND IMPLEMENTATION ORDERING THE EXECUTION OF THE EOP.

WHEREAS, the City of Goodyear (the "City") entered into an Intergovernmental Agreement (the "Agreement") with Maricopa County (the "County") relating to disaster and emergency management services on March 20, 2023; and

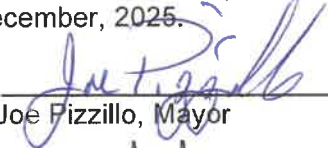
WHEREAS, the Agreement requires that the City develop, publish and distribute an Emergency Operations Plan that is complementary to and compatible with the County's Emergency Operations Plan; and

WHEREAS, the Emergency Operations Plan has been updated and revised and the Council of the City of Goodyear desires to adopt the revised Emergency Operations Plan.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

- SECTION 1. The Emergency Operation Plan, dated November 2025 (the "EOP"), is hereby approved in substantially the form and substance. The EOP is withheld from public disclosure in accordance with Arizona Revised Statutes 41-1803 and will not be attached as Exhibit.
- SECTION 2. The Mayor is hereby authorized and directed to sign the Letter of Approval and Implementation ordering the execution of the EOP substantially in the form and substance, attached hereto as Exhibit "A" and incorporated herein by reference.
- SECTION 3. The Mayor, the City Manager, the City Clerk, and the City Attorney are hereby authorized and directed to take all steps and to execute all documents necessary to carry out the purpose and intent of this Resolution.
- SECTION 4. Resolution 2025-2492 shall be effective upon the date of its adoption.

Approval and Implementation

This is the City of Goodyear Emergency Operations Plan. This plan is the framework for emergency responders, City departments, and supporting agencies to effectively coordinate and collaborate, before, during, and after a disaster, in order to provide a comprehensive response to all emergencies.

The Mayor and City Council authorize the Emergency Manager, as directed by the City Manager, to make changes and updates to this plan that do not materially affect the overall planning approach and do not radically change responsibilities of senior city officials or city departments. Changes will be recorded in the record of changes.

This plan is published in support of the National Response Framework, State of Arizona Emergency Response and Recovery Plan, Maricopa County Emergency Operations Plan, and is in accordance with Arizona Revised Statutes, Title 26, Chapter 2, and Goodyear Code of Ordinances, Article 3-7. This plan supersedes all previously published copies of the Goodyear Emergency Operations Plan.
