

RESOLUTION NO. 2026-2508

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AUTHORIZING THE SUBMISSION OF AN APPLICATION FOR THE ARIZONA DEPARTMENT OF HOMELAND SECURITY GRANT PROGRAM FOR \$244,100, FOR THE GOODYEAR FIRE DEPARTMENT, TO PURCHASE TWO ADVANCED METERING KITS AND ACCESSORIES, AUTHORIZING THE CITY MANAGER, OR THEIR DESIGNEE, TO EXECUTE ALL DOCUMENTS RELATING TO THE GRANT AWARD AND AUTHORIZING A BUDGET TRANSFER TO ALLOW FOR THE EXPENDITURE OF THE GRANT (IF GRANT FUNDS ARE AWARDED).

WHEREAS, it is in the best interest of the Fire Department to apply for the Arizona Department of Homeland Security Grant Program (SHSGP) for the approximate amount of \$244,100 to purchase two advanced metering kits and accessories;

WHEREAS, there is no match requirement for this application;

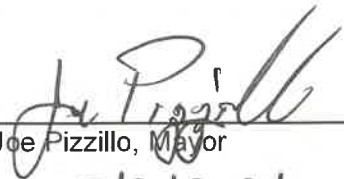
WHEREAS, the project qualifies as an eligible project under the SHSGP grant guidelines; and

WHEREAS, the pursuit of this grant is to the benefit of the citizens of the City of Goodyear.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

- SECTION 1. The City Manager, or their designee, is hereby authorized to submit an application to the Arizona Department of Homeland Security for SHSGP, to purchase two advanced metering kits, accessories and training, not to exceed \$244,100.
- SECTION 2. If the grant application is awarded, the city will enter into a Grant Agreement with the Arizona Department of Homeland Security, to implement the projects or programs that have been approved by the Arizona Department of Homeland Security Grant program.
- SECTION 3. The City Manager, or their designee, is hereby authorized to execute all documents relating to this application and any grant agreement offered as a result of grant funding.
- SECTION 4. If grant funds are awarded to the City of Goodyear, the City Council hereby approves necessary budget transfers in the amount of the awarded funds.
