

RESOLUTION NO. 2026-2533

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON JULY 21, 2026, DECLARING THE ELECTION OF MAYOR, DECLARING THE ELECTION OF COUNCILMEMBERS, CANCELING THE GENERAL ELECTION; AND SETTING AN EFFECTIVE DATE.

WHEREAS, on February 2, 2026, the Goodyear City Council adopted Resolution No. 2026-2509 calling for a Candidate Election to be held in conjunction with the Primary Election on July 21, 2026, for the purpose of electing one Mayor and three Councilmembers to serve four-year terms beginning January 1, 2027;

WHEREAS, the City of Goodyear, in partnership with Maricopa County Elections, conducted the Primary Election called by Resolution No. 2026-2509 on July 21, 2026;

WHEREAS, Arizona Revised Statute §16-642(A) requires that the governing body shall hold a meeting to adopt a canvass of the result of the election not less than six days nor more than twenty days following the election; and

WHEREAS, the returns of the Primary Election have been presented to and canvassed by the City Council of the City of Goodyear.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

SECTION 1. The total number of ballots cast at the Primary Election held on July 21, 2026, was 17,049, and the total number of registered voters was 66,092, as set forth in Exhibit A, attached hereto and incorporated herein by reference.

SECTION 2. The total number of rejected and late ballots was 140, as set forth in Exhibit B, attached hereto and incorporated herein by reference

SECTION 3. The total number of provisional ballots was 25, of which 7 were accepted and 18 were rejected, as set forth in Exhibit C, attached hereto and incorporated herein by reference.

SECTION 4. The votes cast for the candidates for Mayor were as follows:

Bill Stipp	3,622

SECTION 5. It is hereby found, determined, and declared of record that the following candidate for Mayor received the greatest number of votes cast for the office of Mayor and shall be issued a certificate of election.

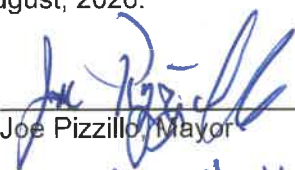
