

RESOLUTION NO. 2026-2535

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, DESIGNATING THE CHIEF FISCAL OFFICER FOR OFFICIALLY SUBMITTING THE FISCAL YEARS 2026 AND 2027 ANNUAL EXPENDITURE LIMITATION REPORT TO THE ARIZONA AUDITOR GENERAL.

WHEREAS, A.R.S. §41-1279.07(E) requires each county, city, town, and community college district to annually provide to the Arizona Auditor General by July 31 the name of the Chief Fiscal Officer the governing body designated to officially submit the current year's annual expenditure limitation report (AELR) on the governing body's behalf;

WHEREAS, Entities must submit an updated form and documentation for any changes in the individuals designated to file the AELR;

WHEREAS, Resolution No. 2026-2502 designated Michael Shoemaker as Chief Fiscal Officer for the Fiscal Year 2025 and 2026 Annual Expenditure Limitation Report ("AELR");

WHEREAS, Resolution No. 2026-2527 designated Paul Luizzi as Chief Financial Officer for the Fiscal Year 2027 AELR;

WHEREAS, the governing body now desires to repeal both of the resolutions previously adopted and designate a new Chief Fiscal Officer for purposes of preparing, signing, and submitting the AELR; and

WHEREAS, the City of Goodyear Mayor and Council desires to designate Laura Calder, as the City's Chief Fiscal Officer.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

SECTION 1. Laura Calder is hereby designated as the City's Chief Fiscal Officer for purposes of submitting the fiscal year 2026 and 2027 AELR to the Arizona Auditor General on the governing body's behalf.

SECTION 2. Resolution No. 2026-2502 and 2026-2527 are hereby repealed in their entirety.

SECTION 3. Resolution No. 2026-2535 shall be effective upon the date of its adoption.
